





Bitcoin ETF Approval Demonstrates Insatiable Demand and Opportune Timing for Digital Asset ETPs

The recently launched Blackrock and Fidelity Bitcoin ETFs in the USA achieved unprecedented success by each accumulating over US\$3 billion in AUM within the first 30 trading days, demonstrating the pent up demand for exchange-traded digital assets. This milestone marks them as the two most successful ETF launches in history out of the more than 5,530 launches that preceded them.
